The Caribbean Disaster Emergency Management Agency (CDEMA) celebrates its silver anniversary in 2016. It has been 25 years since the CARICOM Heads of Government in recognition of the fragile economies and ecosystems of the States within the Caribbean region being extremely vulnerable to natural and man-made hazards, demonstrated the foresight to establish a regional CARICOM Mechanism for emergency response and disaster relief.

The regional Agency was first established in 1991 as CDERA (Caribbean Disaster Emergency Response Agency) with primary responsibility for the coordination of emergency response and relief efforts to Participating States that require such assistance. It transitioned to the Caribbean Disaster Emergency Management Agency (CDEMA) in 2009 to fully embrace the principles and practice of Comprehensive Disaster Management (CDM) and to advance the work of CDERA by ensuring

Over the 25 years, the CDEMA System has learned, adjusted, improved and retooled to meet the demands of each stage of the journey. The disaster events of the last decade and the climate threats facing the region today and in the future are a testament to the foresight of the Region's Leaders back in 1991. It further underscores the relevance and mandate of CDEMA as an institution equipped with the experience and knowledge to offer solutions to the current climate change dilemma.

A major achievement of the Agency is the development and implementation of the CDM Strategy now in its third iteration for 2014 -2024. CDM is an integrated risk man agement strategy, developed first in 2001 as a blueprin for guiding disaster management interventions in the Car ibbean region. CDEMA also plays a key role in develop ing a regional level framework for risk reduction and coordinating interventions at the regional level to enhanc disaster resilience within the Caribbean region. In thi regard, CDEMA has over the years developed a numbe of model tools and provides support to Participating States in adapting these at the national level. CDEMA also maintains its primary function, which is the coordina tion of response support to Participating States affected by an emergency event, once the State requests such as sistance, through the Regional Response Mechanism (RRM). CDEMA's successes are therefore largely due to the solid partnerships with its 18 Participating States regional institutions, international development partner and donors.

In celebrating this very important milestone, CDEMA would like to thank its stakeholders and partners for thei unrelenting support over the past 25 years and looks for ward to a prosperous relationship for next 25 years.

From the ED's Desk: CDEMA's 25th—Reflection and Recommitment

As I reflect on the creation of the Agency I serve, I am reminded of a line in the Jamaican National Anthem: "Give us vision less we perish". I believe the CARICOM Leaders showed great vision in the creation of the Caribbean Disaster Emergency Response Agency, in September 1991 as an institution of CARI-COM recognized under Article 21 of the Treaty of Chaguaramas. The Agency was created with the full recognition of the fragile economies and ecosystems of countries within the region, and was established with the necessary organs, membership, structure and functions to serve as the regional disaster management body with primary responsibility for coordinating emergency response and relief efforts provided to Participating States that require such assistance. CDERA transitioned to CDEMA in 2009 to advance the work of CDERA and with an enhanced mandate to promote disaster loss reduction and ensure the sustainable development of resilient communities within the Caribbean Region. It is also mandated to perform the role of facilitator, driver, coordinator and motivating force for the promotion and engineering of Comprehensive Disaster Management (CDM) in its 18 Participating Member States in the Caribbean lenges ranged from waning support from Community. It is therefore 3. necessary at this stage to acknowledge the dedication and hard work of the pioneers, leaders, current and former staff members and supporters throughout the CDEMA System for achieving admirable results in 4. disaster management across the region over the years. Without their contribution and commitment a silver jubilee would not have been realized.

The CDEMA System has much to be proud of. We have led the development and implementation of the Comprehensive Disaster Management (CDM) Strategy since 2001. which serves as a road map for delivering effective disaster risk reduction and resilience programmes at the national and regional levels. We have demonstrated growing capabilities over these 25 years through the strengthening of national preparedness and operational capacities as well as coordinating regional response mechanisms to aid in the relief and response efforts to affected Member States.

Our implementation of the CDM Strategy, now in its third iteration (2014-2024), has provided us the opportunity to focus our efforts on being far more proactive rather than reactive in dealing with disasters risks. The work of CDEMA through the CDM Strategy has contributed to the development of a more organized framework for the management of hazard and disaster risks in our region.

Whilst the journey thus far has been rewarding, the Agency faced numerous challenges over the 25 years but despite the challenges we remained committed to the vision. CDEMA hosts 7th Council of Ministers Meeting in Barbados



The 7th Meeting of the Council of Ministers was held at the CDEMA's Headquarters in Barbados on June 22, 2016. The Council is CDEMA's highest decision making body and is mandated to meet in ordinary session annually.

Representation of the 7th meeting of the Council included Ministers of Government, Senior Government Officials and National Disaster Coordinators from across CDEMA's Participating States.

Key items discussed at the meeting included the level of national operational readiness for possible disasters, especially during the hurricane season. The session noted the importance of countries to be ready and prepared at all times to protect lives, property and infrastructure.

The meeting also discussed the sustainable financing efforts of the CDEMA Coordinating Unit (CU). To this end, the report from the Management Committee of Council pertaining to the financial and administrative matters of the CDEMA CU was reviewed. The CDEMA CU's 2 year work programme was also approved and adopted by The Council.

The new Deputy Chairman is the Honourable Winston Garraway, Minister of National Security, Disaster Management, Home Affairs, Information and Implementation, Government of Grenada. The meeting also recognized and thanked the previous Chairman, Honourable Adriel Brathwaite, Attorney General and Minister of Home Affairs, Barbados. Special recognition and gratitude was extended to the former Deputy Chairman and Deputy Governor of Anguilla, Honourable Stanley Reid. Mr. Reid served as Anguilla's representative to The Council for the past 10 years.

Training for CARICOM's Primary Humanitarian Relief Unit

Thirty two (32) participants from the disciplined forces, including police, military and fire services, successfully completed four days of training in preparation for their role in providing relief and humanitarian assistance in the event of a disaster. The annual training workshop of the CARICOM Disaster Relief Unit (CDRU) was held at the CDEMA's headquarters in Barbados from August 8th to 12th 2016.

The training was facilitated by CDEMA in collaboration with the Regional Security System Headquarters (RSS HQ) with funding from the United States Government through the US Southern Command. The CDRU is one of the specialised teams trained by CDEMA each year as part of the Regional Response Mechanism (RRM). The RRM is coordinated by CDEMA to provide humanitarian and technical support in a

timely manner if requested by any of the CDEMA's 18 Participating States. The System is extremely dependent on the readiness and willingness of the governments of Participating States, regional institutions, key development partners, agencies of the United Nations and humanitarian partners to work together in offering immediate

assistance when the call comes from the CDEMA Coordinating Unit. The CDRU is deployed to provide humanitarian assistance in direct support to the civil authorities of any State affected by natural or technological hazards.

The CDRU's mission is to conduct disaster response and relief operations and its main tasks include the management of relief supplies, emergency telecommunications and the provision of appropriate personnel for repairing critical lifeline facilities. The four day training included introductions to Disaster Management, National Disaster Management and the National Emergency Operations Centre (NEOC), introductions to the Regional Supply Tracking System (RSTS), Incident Command System, Urban Search and Rescue in CDEMA Participating States, Dignity and Human Rights and Civil/Military Coordination.

Belize Impacted by Hurricane Earl

In the early hours of Thursday August 4th 2016, Hurricane Earl made landfall near Belize City. Earl impacted Belize as a Category 1 Hurricane with estimated maximum sustained winds of 80 mph. Earl moved westward at a speed near 14 mph and produced rainfall of 8-12 inches resulting in severe flooding over Belize. The system took about fifteen hours to cross the country. The areas most impacted included Belize City, Belize Rural, Orange Walk, Cayo, and the Stann Creek districts.

There were no reports of fatalities and no reports of injured and missing persons. In Belize City the Police and the Fire Departments conducted 274 rescues. At the height of the storm 3,500 persons were in 94 shelters across the country. Many roads and bridges were impassable and structural damage reported to houses, businesses, government and private buildings. The final damage assessment by the National Emergency Management Organization (NEMO) amounts to millions of dollars in material losses. The Regional Response Mechanism (RRM) was placed on alert while the CDEMA CU remained in contact with the Government of Belize and provided some support in mobilising Emergency Response Grant (ERG) to support recovery efforts. CDEMA is also exploring other avenues for funding to assist with community rehabilitation support.

Hurricane Matthew: CDEMA's Response to Impacted States

Matthew, the 5th named hurricane of the 2016 Atlantic Hurricane season, was formed near the Windward Islands on September 28, 2016. As a Tropical Storm, Matthew impacted Barbados, Dominica, Saint Lucia, and St. Vincent and the Grenadines on Wednesday September 28, 2016. Heavy rains and strong

winds were experienced Ewing (st

in these countries over a period of 24 hours, resulting in flooding, landslides and some damage to infrastructure. There was one report of fatality in St. Vincent and the Grenadines. Saint Lucia suffered most in terms of damage to residential homes and businesses, blocked road ways and severe flooding at the Soufriere Hospital, which was relocated to the Environmental Health Building at Deliau Street, Wingsville. 133 persons were also reported in shelters throughout the island.

As a Hurricane, Matthew impacted Jamaica on the 3^{rd} ; Haiti on the 4^{th} and The Commonwealth of The Bahamas during 4^{th} - 6^{th} October, 2016. No deaths or injuries were reported in Jamaica however, 3,500 persons were in 193 shelters across the island.

as a Category 4 hurricane on the Saffir-Simpson Hurricane Wind Scale with maximum sustained winds up to 140 mph (220 km/h) with higher gusts and subsequently severe impacts to The Bahamas as a Category 3 with maximum sustained winds of 120 mph. CDEMA activated the Regional Coordination Plan and the Regional Coordination Centre (RCC). In efforts to assist these countries in dealing with the aftermath of the hurricane, CDEMA also deployed 2 sets of specialized response teams to Haiti and The Bahamas.

At the request of the Government of Haiti and based on priority needs identified, CDEMA deployed a 6 member CARICOM Operational Support Team (COST) to Haiti on Friday, October 7, 2016. The COST support Emergency Operation Centre (EOC) coordination

in Jérémie and Les Cayes, two settlements most affected by Hurricane Matthew. The team was led by Brigadier General (Ret'd) Earl Arthurs and supported by technical personnel from CDEMA Participating States.

Three (3) Rapid Needs Assessment Teams (RNATs) were also deployed to The Bahamas on Friday October 7, 2016 on the request of NEMA, Bahamas. The teams included representatives from UNDAC, CARPHA and CDEMA and were led by Ms Joanne Persad, Programme Manger, Preparedness and Response, CDEMA. The RNATs facilitated initial damage assessments and needs analysis in Andros, Grand Bahama and New Providence Islands.

CARICOM High Level Delegation visited Haiti & The Bahamas in the aftermath of Hurricane Matthew

A high level delegation visited Haiti on October 11, 2016 and The Bahamas from October 12-13, 2016. The delegation discussed support with the leadership of the affected States and confirmed additional areas where the Community could provide support. Members of the delegation included: The Honourable Roosevelt Skerritt, Prime Minister of Dominica and Chairman of the Conference of Heads of Government of Caribbean Community, Ambassador Irwin Secretary General of CARICOM,

Mr. Ronald Jackson, Executive Director of CDEMA, Honourable Saboto Caesar, Minister of Agriculture St. Vincent and the Grenadines supported by a technical representative from the Food and Agriculture Organization (FAO), Dr. David Farrell, Principal of the Caribbean Institute for Meteorology and Hydrology, who joined specifically for the Haiti segment.

Emerging from the high level dialogue, additional support was recommended for Haiti that focused on providing targeted assistance in a specific geographical locale and for a specific purpose. As such the CARICOM support was concentrated in the Sud Department, specifically in Les Cayes and Jeremie. To this end, resources were garnered from Member States to provide the well needed support to the worst affected population in these two areas for a maximum period of one month.

The Community also agreed to focus its intervention on rehabilitating the education infrastructure. A school feeding programme was supported for 2 weeks catering to children and families displaced as a result of Matthew.

CARICOM's Intervention in Haiti, post Hurricane Matthew a Success

The Caribbean Community's (CARICOM) response to the devasta- Turks and Caicos Islands and the Caribbean Media Corporation tion in Haiti as a result of Hurricane Matthew on October 4, 2016 is (CMC). deemed a resounding success. CARICOM's response was led by CDEMA in providing emergency relief supplies and early recovery operations in the two most affected areas of Les Cayes and Jérémie.

As part of a legacy intervention, CARICOM supported the rehabilitation of the Ecole Nationale De Sicard de Pelerin School in Les Cayes and a feeding programme for the students for a period of two weeks. The CARICOM response also provided US\$53,000 in relief supplies (including items such as tarpaulin, water, protein, starch, hygiene products and supplies for babies) to 805 families in Les Cayes.

Additionally, the Government of the Commonwealth of Dominica shipped two 20ft containers of relief supplies to Haiti and provided cash donations of US\$100,000 to support CARICOM efforts. The Government of Jamaica also shipped two 20ft containers of relief supplies donated by the people of Jamaica while the Government of the Turks and Caicos Islands provided cash donations of US\$50,000 and personnel to also aid the recovery and relief process.

Noting that the relief and early recovery operations in Haiti have come to a close, CDEMA's Executive Director, Mr. R. Jackson said, "The success of the mission would not have been possible if it wasn't for the personnel, the regional response teams, the contributions made by CDEMA Participating States, regional and international partners including the United States Southern Command and the World Food Programme (WFP). On behalf of the CDEMA System and the wider Caribbean Community, I wish to recognise and thank them all for their contributions". The Executive Director also expressed gratitude to Digicel Business (Barbados) for demonstrating their support by offsetting the costs for calls and data usage incurred by CDEMA's staff during the response period.

"The efforts spearheaded by CDEMA underscore the importance and urgency in which the region needs to continue to strengthen its capacity. We need to identify sustainable mechanisms to finance these systems so we can continue to serve the needs of our Participating States in a predictable way", added Mr. Jackson.

The region's response started with the deployment of the CARICOM Operational Support Team (COST) between October 7th and 19th, 2016 at the request of the Government of Haiti. The COST provided direct support to the Emergency Operation Centres of Les Cayes and Jérémie by compiling data, generating information, coordinating both external and internal resources, as well as generating reports. The team was led by CDEMA and supported by technical personnel from Barbados, Jamaica, Montserrat, Saint Lucia, Trinidad and Tobago,

Highlighting the valiant efforts and contributions to the early recovery process by the local Haitian officials, retired Brigadier General Earl Arthurs, CDEMA's Operations Specialist and Special Coordinator on the ground in Haiti said, "I think one of the major achievements of the mission was the show of ownership and leadership by the Haitian Directorate of Civil Protection (DPC) of the response operations at the National and Departmental levels". General Arthurs who was stationed in Haiti with the COST for four weeks also stressed the high level of participation of all the relevant sectors in meetings. He also commended the high standard of the Situation Reports produced and circulated by the DPC Haiti throughout the period. Following General Arthurs redeployment, Lt. Colonel Clyde Parris served as Special Coordinator for the CARICOM response in Haiti.

In addition to the COST, a CARICOM Disaster Relief Unit (CDRU) team was deployed to assist with the distribution and management of relief supplies. Deployment of the CDRU and the Jamaica Defence Force (JDF) personnel was facilitated by the Regional Security System (RSS) and the Government of Jamaica. The CDRU also assisted with establishing High Frequency radio communication between Jérémie and Les Cayes.

The rehabilitation of the school was facilitated by Structural Engineer, Grenville Phillips, who donated his time to provide supervision and onsite training to Haitian artisans. Military engineers from the JDF also facilitated the repairs to the school in Les Cayes as well as provided military security for the CARICOM humanitarian actors on the ground, including members of the CDRU and COST.

All teams that were deployed to Haiti were redeployed by November 16, 2016 signaling the end of the operations.

Daily weather analysis and briefings was provided by the Caribbean Institute for Meteorology and Hydrology (CIMH) in supporting the preparedness and response teams in Haiti to inform operations. The Government of Haiti reported that Hurricane Matthew resulted in 546 deaths; 1,410,774 persons being in urgent need of humanitarian assistance at the height of the emergency and 120,000 families had their homes destroyed or damaged.

CDEMA and IDEA International Awarded Silver Medal

CDEMA is the recipient of a Silver Medal award which is shared with the Institute for Development in Economics and Administration (IDEA International). The award was sponsored by the International Development Bank (IDB) and presented during the IX International Seminar of the Sub-National Governments Network (CoPLAC) held in Guadalajara, Jalisco, Mexico on September 8th, 2016. Both entities were

for Development Results (MfDR)' and were placed second in the 'MfDR in Sectors' category.

"Being awarded this Silver Medal on the occasion of celebrating our Silver Anniversary is highly commendable and speaks to the growth of the Agency over the past 25 years in ensuring that M&E is highly featured in our efforts to be accountable to our Participating States and stakeholders as we report on progress towards the achievement of the Regional Comprehensive Disaster Management (CDM) Strategy 2014-2024 and the CDEMA Coordinating Unit (CU) Corporate Plan 2014-2017", commented Mr. Jackson on receiving the award.

In 2013, the CDEMA CU contracted the IDEA International Institute to provide support to strengthening the MER capacity of the Agency to lead the CDM agenda for the region. The project undertaken by IDEA started with a series of training in Monitoring & Evaluation (M&E) of a critical mass of key actors, both at CDEMA CU and in major National Disaster Offices. Twenty one participants achieved the Masters Certification Programme in M&E and Information Systems, a graduate level credited programme offered jointly by IDEA International and University Laval, Canada.

Further work on the M&E system involved the revision of the strategic and operational plans, adjusting when necessary the choice of indicators in the Performance Measurement Framework, and checking for the consistency of targets set at strategic, program-

matic, and operational levels over the planning horizon of the CDM Strategy. The development of such a robust system also includes efforts to strengthen M&E at the level of the National Disaster Management Organizations. And finally, the initiative was accompanied by the design and implementation of an online monitoring system, which started with a diagnostic of needs and of relevant existing information systems, and then included the adaptation of the generic IDEA Solutions "Monitoring for Results" (M4R) software to the specific needs and characteristics of CDEMA to develop a tailor-made solution, which is currently functional as CDM Monitor.

Based on the support given by IDEA, the CDEMA CU has seen an improvement over the last 3 years in its internal systems in terms of monitoring and reporting of results. The CU is also providing support to the Participating States and to stakeholders within the CDM Governance Mechanism in order to improve the level of reporting on progress of implementation of the CDM Strategy.

CDEMA and CBU Signed MOU CDEMA Strengthens Collaboration with Dominican Republic



Mr Ronald Jackson, Executive Director of the CDEMA Coordinating Unit and Mrs Shida Bolai, President of the Caribbean Broadcasting Union (CBU), signed historic Memorandum of Understanding (MOU) to further collaborate and maximise on mutual benefits in raising awareness on Comprehensive Disaster Management (CDM) and increased media role in promoting disaster preparedness and response in the region. The MOU signing took place on October 25th at the 47th Annual General Assembly in Havana, Cuba.

Speaking during a discussion on Disaster Risk Reduction, Mr Jackson also called on the region's media to become more of an ally in drawing public attention to the commitment gap among the region's political directorate and decision makers to invest more on prevention and mitigation strategies. In an effort to strengthen cooperation among disaster and emergency management agencies across the region, CDEMA signed a Memorandum of Understanding with the National Emergency Commission (CNE) of the Dominican Republic.

The MOU, which was signed on June 6th by Mr. Ronald Jackson of CDEMA and Major General Rafael E. Pichirilo of the CNE, aims to establish a general framework of cooperation and partnership between the institutions. The agreement covers areas of mutual interest and efforts to support the regional disaster resilience building agenda within the Caribbean and more particularly between CDEMA Participating States and the Dominican Republic. The two institutions seek to complement efforts and create synergies in which each partner's advantages

are enhanced, capitalizing on the experience and for the purpose of undertaking joint actions in areas of interest. This would also include the design of strategies and actions aimed at capacity building within CDEMA Participating States and the Dominican Republic in relation to Compre-

hensive Disaster Management. During his official visit to the Dominican Republic, Mr. Jackson also met with Ambassador Antonio Vargas Hernandez, the NAO of European Funds for Development and Director General of Multilateral Cooperation (DIGECOOM). Ambassador Vargas Hernandez expressed his satisfaction with the signing of the MOU between the two Agencies and said that by order of the President Danilo Medina, the institution he leads has advocated and promoted closer cooperation with the Caribbean. He also highlighted the need for greater collaboration in integrating disaster risk management in academics, specifically in the curricula of schools and universities in the Dominican Republic.

Jeremy Collymore Honoured by the Government of Barbados

The former Executive Director of the Caribbean Disaster Emergency Management Agency (CDEMA), Jeremy M. Collymore was recently honoured by the Barbados Government for his outstanding contribution and leadership in Disaster Management at the national, regional and global levels. Collymore was honoured with the Barbados Service Star at the Awards of National Honours, on the celebration of Barbados' 50th anniversary of Independence on November 30th, 2016.

In his quiet and appreciative demeanor Collymore said, "I am indeed grateful to be recognised for my work although I never really worked for an award." Mr. Collymore, who has served the region for more than 30 years by leading disaster response coordination at the national and regional levels, is also a strong advocate for cultural change to building disaster resilience in the Caribbean, and continues to do so as an Honorary Research Fellow at the Institute for Sustainable Development, UWI. "I see myself as a flag bearer in the disaster management community. Mr. Collymore was the first and only Coordinator of the Caribbean Disaster Emergency Response Agency (CDERA) established in 1991 as the lead CARI-COM regional agency for disaster emergency response coordi-One of his major nation. "pioneering" achievements included championing and leading the paradigm shift of regional disaster management thinking from a response tradition to a Comprehensive Disaster Management (CDM) approach. The adoption of the CDM approach by CARICOM in 2001 also resulted in Collymore overseeing the transition of CDERA to CDEMA (Caribbean Disaster Emergency Management

Speaking at the brief signing ceremony, Mr. Ronald Jackson said, "This relationship between CDEMA and CARICAD has been brewing for some time and we are particularly proud to share this moment where we formalize a partnership to support institutional strengthening of the public sector across the region. CDEMA and CARICAD share common challenges including those of predictable financing, that all regional institutions face and which presents significant

The Intra-ACP European Union Sponsored Country Directed Fund (CDF) Small Grants Highlights 2016

Antigua and Barbuda – Community Emergency Response Teams (CERT) Training



The Antigua and Barbuda National Office of Disaster Services (NODS), in collaboration with the Fire Department, St. John's Association and the Red Cross, trained 79 volunteers as part of the Community Emergency Response Team (CERT) training initiative in an effort to establish an island-wide CERT-network and enhance disaster management at the community level and strengthen response and basic search and rescue capability at the local level.

The training sought to improve basic first aid, relief efforts, road clearance, damage assessment, basic search and rescue, fire fighting, and generally create enhance capacity for district to district support in times of emergencies/disasters.

It is expected that this will result in increased capacity for preparedness, response, and mitigation in communities in Antigua and Barbuda and strengthening of

community-level disaster management structures.

Grenada – Plans Review & Development Workshop

The Grenada National Disaster Management Agency (NaDMA) conducted a Plan Review and Development Workshop to support enhanced coordination and harmonizing of disaster management efforts in Grenada. The workshop focused on providing updated plans and SOPs to reflect the current situation, foster efficient disaster management and to guide the way the National Disaster Organisation respond to emergencies.

The participants included 15 members of the National Emergency Advisory Council (NEAC), 17 District Coordinators, 9 staff members of NaDMA and 6 representatives from Grenada Red Cross and Utility Companies.

During the three-day Workshop Grenada's Disaster Plan and the Emergency Operations Centre (EOC) manual were reviewed and framework plans for Tsunami, Earthquake and Evacuation were developed. In addition, the Caribbean Disaster Emergency Management Agency (CDEMA) model plans were utilised during the process.

St. Vincent and The Grenadines – Volcano Awareness Activities 2016

The St. Vincent and the Grenadines National Emergency Management Organisation (NEMO), in collaboration with the Seismic Research Centre (SRC) of the University of the West Indies, The Strengthening Resilience in Volcanic Areas (STREVA) Project, Soufriere Monitoring Unit (SMU), Forestry Division, Ministry of Agriculture, Forestry and Fisheries and Ministry of Education, conducted a public education and awareness campaign (Volcano Awareness Week of Activities 2016) as a means of strengthening and sustaining community resilience to hazard impacts using approaches that are culturally appropriate. The activities included school visits, radio discussions, television broadcasts, public presentations and an Educational Field Tour to the La Soufriere Volcano.

The purposes of the series of activities were to raise awareness of the risk and science associated with an active volcano, to strengthen the planning for volcanic hazards in schools in high risk areas, to give community members in high risk areas the opportunity to explore responses to the acute phase of an eruption of the La Soufriere Volcano (how to reduce risk to life), and also to discuss longer-term effects of an eruption (how to reduce risk to livelihood), through scenario exercises.

The participants included 30-35 Key national stakeholders, who play a key role in the National Volcano Emergency Plan when activated. Twenty five (25) teachers from Primary and Secondary Schools within the Red and Orange Zones and a total of 558 students. which included 360 grade five and four students from 13 Primary schools and 198 form four and five students also participated in the exercise. These schools are located within the Red and Orange zones and are residents of the communities of Fancy, Owia, Overland, Orange Hill, Georgetown, Chateaubelair, Richmond, Troumaca and Rose Hall. Thirty (30) geography students and 2 teachers from the Georgetown Secondary School and 50 students and 2 teachers form the Sandy Bay Government School as well as 60 members of the public benefitted from the Educational field tour .

World Tsunami Awareness Day Celebrated in the Region

For the first time, World Tsunami Awareness Day (WTAD) was commemorated all around the world in order to raise awareness on the importance of tsunami preparedness and to reaffirm the inherent links

tainable development. CDEMA joined with its national, regional and international partners in recognising and celebrating WTAD 2016. This year the events focused on effective education and evacuation drills. One example from the Caribbean and Adjacent Regions is the Caribe Wave Exercise, which happens every year.

WTAD aims to raise public awareness of the deadly threat posed by tsunamis and share innovative approaches to reducing risk. The worldwide events, supported by the Government of Japan, presented an opportunity to showcase good practices related to Tsunami readiness and supported the implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030 as well as the Comprehensive Disaster Management Strategy 2014-2024, contributing to greater risk understanding and reduce mortality, vulnerable region to earthquakes and tsunamis, in such a way that is expected that one destructive tsunami will take place every fifty years. There is currently a major effort to build upon and reinforce initiatives that aim to strengthen tsunami resilience such as the Caribbean Hazard Mitigation Capacity Building Programme (CHAMP), the Tsunami Smart Campaign launched by the CDEMA, in conjunction with the UWI Seismic Research Centre as well as the efforts undertaken by the Intergovernmental Coordination Group for the Tsunami and other Coastal Hazards Warning System for the Caribbean and Adjacent Regions (ICG/CARIBE).

The commemoration in the Caribbean region of WTAD was held on 20th October 2016 and jointly organized by UNISDR, UNESCO/IOC, the ACS, CDEMA as well as CEPREDENAC.
