



CDEMA COUNCIL'S AWARD

The CDEMA Council's Award is the highest award of the Caribbean Disaster Emergency Management Agency (CDEMA) in recognition and honour of significant long-term efforts and contributions which have clearly influenced the advancement of Comprehensive Disaster Management in the CDEMA Participating States.

Eligible Recipients

Any individual, Agency, Institution or Association (including NGOs, CBOs, Private Sector entities) involved in disaster management in one or more of the CDEMA Participating States.

Criteria for Award

This highest and prestigious award recognizes and honours an individual, organisation or other entity that invests time and resources to make positive changes by:

- Supporting or being responsible for the development of programs aligned to the priority areas of the CDM Strategy which fundamentally change the delivery of disaster management for the better;
- Motivating people or organisations to become actively involved in comprehensive disaster management;
- Working for long-term changes which have positive national and/or regional implications with regard to strengthening disaster resilience

Award Presentation

The Award will be presented to an individual, Agency/Institution/Association at the Gala Closing, Dinner and Awards Ceremony of the 11th Caribbean Conference on Comprehensive Disaster Management on Friday, December 6, 2019 at the Sonesta Maho Beach Resort, Sint Maarten.

Method of Application

No candidate may nominate himself/herself or his/her organisation. Nomination through the attached form must be completed and supported by two references. Power-point presentations or other electronic illustrations of achievements may be submitted with application.

Submission of Application

Deadline for applications is **October 25th 2019 at 11:59p.m. (Barbados time)**
