

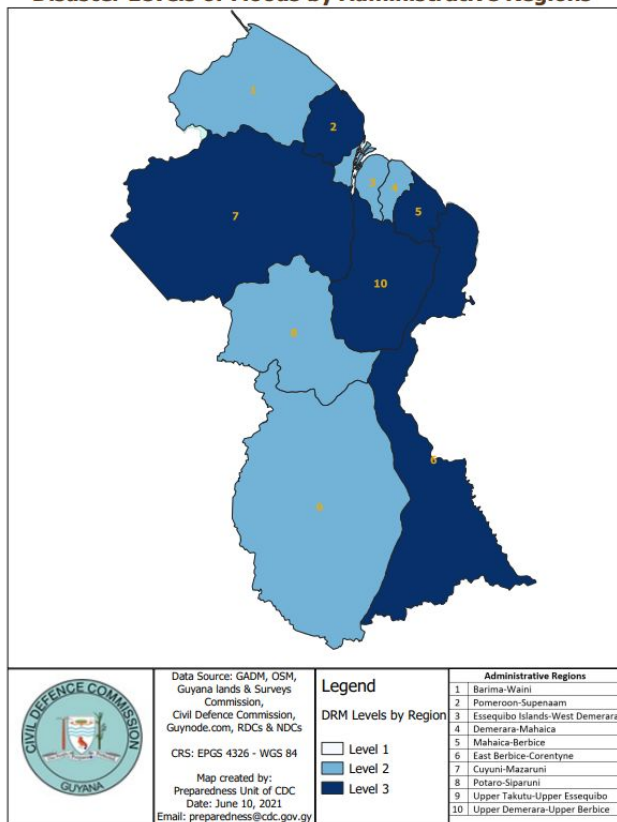
Guyana impacted by flooding

SITUATION OVERVIEW

LEVEL 2 EMERGENCY RESPONSE EVENT

- A Tropical Wave embedded within the ITCZ affected Guyana resulting in heavy rainfall during the month of May into June. Over the past two days, the Civil Defence Commission (CDC) has continued to receive reports of flooding across the country. Through the powers conferred upon the Head of State by Article 99 of the Constitution, the President, His Excellency Mohammed Irfaan Ali declared a disaster in the Co-operative Republic of Guyana by virtue of flooding on June 9, 2021. This proclamation was published in the Official Gazette on June 10, 2021.

Disaster Levels of Floods by Administrative Regions



The CDC continues to provide direct support in the areas of shelter management, evacuation, relief distribution across the country, especially in Regions and communities where excessively high water levels are being experienced. Regions 10, 7, 6, 5 and 2 are the most impacted.

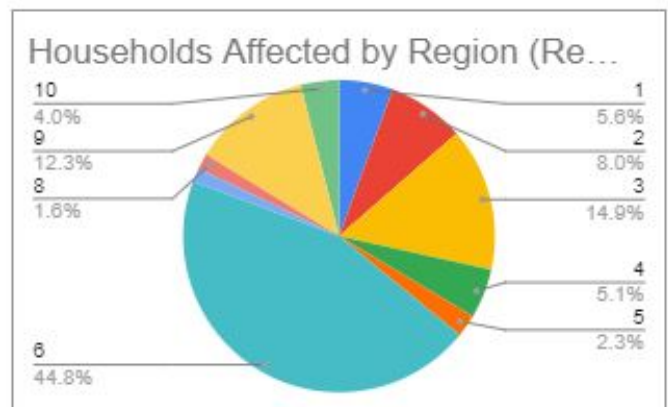
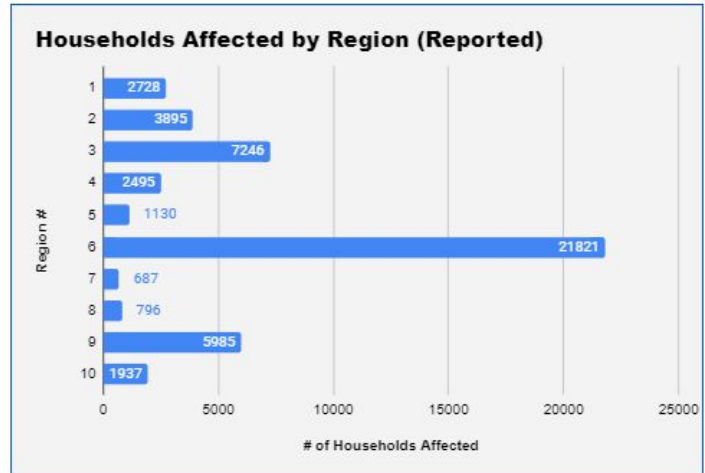
Detailed Damage Sectoral Assessment (DDSA) Teams are currently on the ground in Guyana.



Updates from Impacted CDEMA Participating State

The Situation Report by the Civil Defence Commission (CDC), Guyana issued on 21 June, 2021 stated the following:

- CDC continues to receive and verify reports of severe flooding across communities with water entering homes, livestock and domestic animals in distress and farmlands inundated and resulting crop damages.
- Regions 10, 7, 6, 5 and 2 are the most impacted.
- The CDC has received reports of 48,720 households suffering flooding in more than 300 communities across all ten (10) Administrative Regions.
- A total of 216 persons are currently being housed in a total of 9 shelters activated in Regions 2, 5, 9 and 10.



Since May 18 2021 the CDC has received reports of 48 720 households suffering flooding in more than 300 communities across all ten 10 Administrative Regions.

GRAND TOTAL (REPORTED) =48,720

Humanitarian Assistance

During the period of May 18 – present, a total of 24,160 cleaning hampers and 29,221 food hampers have been distributed across the Regions as a form of emergency relief.

Distribution



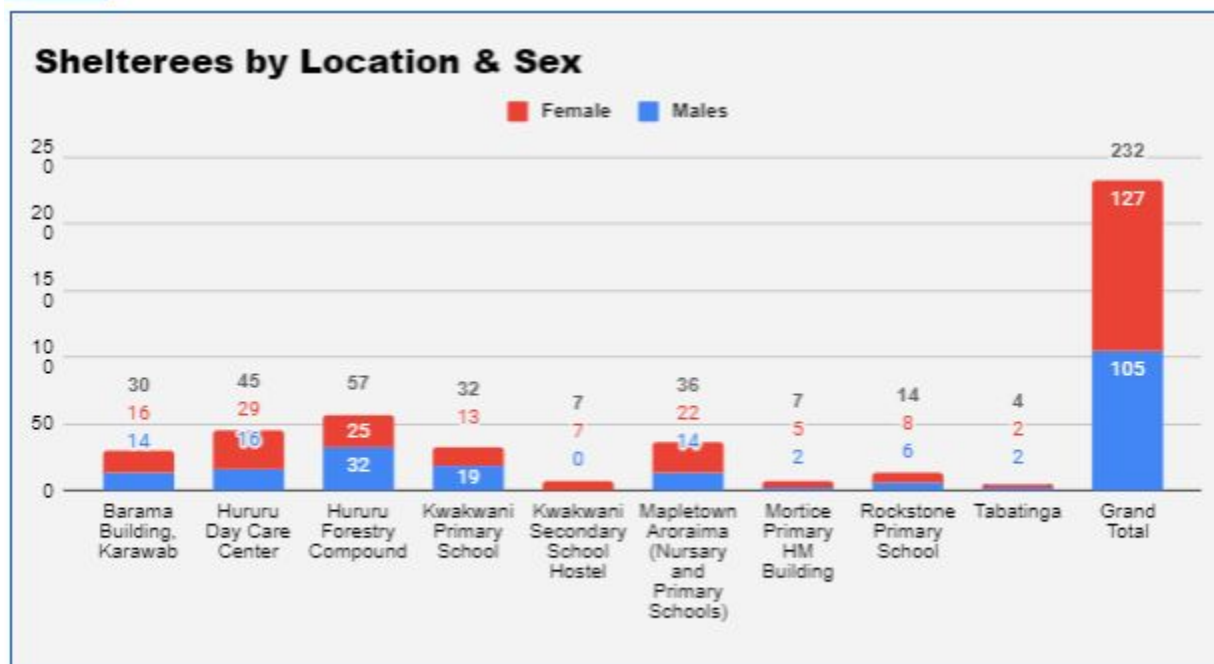


Updates from Impacted CDEMA Participating State

Civil Defence Commission (CDC) Response Actions:

- Activated the National Emergency Operations Centre (and led the development of an action plan for the national flood response
- Continues to dispatch emergency relief supplies to flood affected Regions and communities
- Continues to manage and support shelter operations in Regions where these are activated
- Continues to engage CDEMA, other regional and international stakeholders for support to national flood response
- Has kept the public updated through regular press releases, interviews and alerts
- Continues to provide technical support to the Regional Emergency Response System
- Continues to acquired financial support and relief supplies from the Private Sector, NGOs and private citizens

SHELTERS: A total of 232 persons are currently being housed in a total of 9 shelters activated in Regions 2 ,5, 9 and 10

Coordination of the Regional Response Mechanism (RRM)

- The CDEMA Advanced team arrived in Guyana on June 17th and remain in theater to date.
- Five (5) Detailed Damage Sectoral Assessment (DDSA) teams were officially deployed to Guyana to report on the flooding impacts on sectors within the island in the areas of health, mining, agriculture, infrastructure, housing, water, sanitation, shelters and the social sector. The teams are working primarily in Regions 2, 5, 6, 7 and 10. The deployment of the DDSA teams was funded by USAID Eastern and Southern Caribbean through the Caribbean Climate Resilience Initiative which is being implemented by the CDEMA Coordinating Unit.
- The Teams are currently compiling their reports and assessments of the final region is starting.
- CDEMA continues to engage regional and international partners to support Guyana
- A presentation of the interim findings will be undertaken and the full DDSA report will be completed once the final assessment in the last region has concluded.
