CDEMA AND PARTNERS CONTINUE TO COORDINATE RELIEF EFFORTS



Jamaica's Prime Minister, Most Honourable Andrew Holness (centre), met with a High-Level Regional Delegation comprising representatives from Caribbean Disaster Emergency Management Agency (CDEMA), the Caribbean Development Bank (CDB), the Caribbean Institute for Meteorology and Hydrology (CIMH), and the Caribbean Public Health Agency (CARPHA) on November 2nd, 2025.

SITUATION

Regional and international partners are maintaining close coordination to facilitate the shipment of relief supplies into Jamaica in support of ongoing response efforts. The Rapid Needs Assessment Team (RNAT) continues its field assessments to evaluate the extent of damage and identify critical areas requiring humanitarian assistance and support. The high-level delegation from the Caribbean Disaster Emergency Management Agency (CDEMA), Caribbean Development Bank (CDB), Caribbean Institute for Meteorology and Hydrology (CIMH), and the Caribbean Public Health Agency (CARPHA) met with Dr. The Most Honourable Andrew Holness, Prime Minister of Jamaica, today, November 2nd, 2025, and discussed CDEMA's support from pre-deployment to the present, current gaps, and opportunities for further support. They also addressed financial support options through the CDB for response, early recovery, long-term recovery, and institutional strengthening for disaster risk management; climate change, climate adaptation, and resilience issues and how CIMH can provide support. Health considerations post-Hurricane Melissa were also considered, including avenues for support through CARPHA.

JAMAICA

Prime Minister, Dr. The Most Honourable Andrew Holness has declared Jamaica to be a disaster area on October 28th, 2025 in accordance with the Disaster Risk Management Act. This was cited in the [Jamaica Gazette Supplement](#).

Report from the Office of Disaster Preparedness and Emergency Management (ODPEM) in Jamaica

- The National Emergency Operations Centre (NEOC) remains fully activated at Level 3 with support from the Jamaica Defence Force in the areas of Information Management (IM), Logistics and Relief.
- Assessments and relief efforts continue through the ODPEM.
- The RNAT will be assisting with sector assessments already ongoing, which commenced in the parish of Westmoreland.

According to Jamaica Public Service Company Limited (JPS) Restoration work has advanced in the parishes of Kingston and St. Andrew, St. Catherine and St. Thomas. Teams are on the ground continuing damage assessments in these parishes, however, there are some areas which are currently impassable.

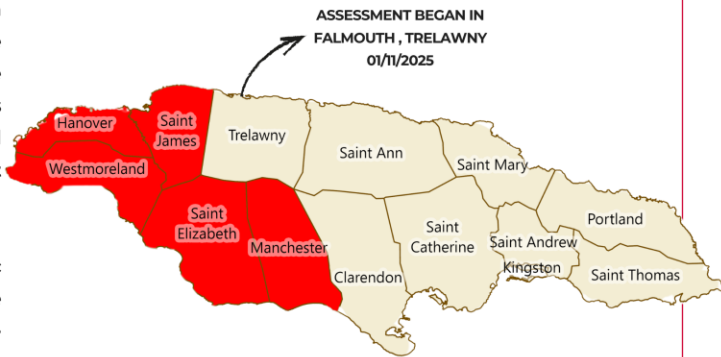


JAMAICA (Continued)

RAPID NEEDS ASSESSMENT TEAM UPDATES - LAST UPDATED 02/11/2025 09:00 HRS

i RNAT officially commenced field operations in Jamaica on November 1st, 2025 following an in-brief session with the Planning Institute of Jamaica (PIOJ). This is the first time the RNAT is being utilized by the Government of Jamaica, and its deployment is being integrated with the national sectoral assessment teams and the Post-Disaster Needs Assessment (PDNA) process.

The RNAT comprises sector experts covering priority thematic areas, including WASH, Education, Health, Coastal and Marine Environment, and Emergency Shelter. A UAV and Starlink-enabling communications capability have been deployed to support field-level data capture and reporting.

COORDINATION



- The Caricom Emergency Telecommunications Team (CETT) team is on the ground and will be joined by additional members this evening November 2nd, 2025.
- The Caricom Operational Support Team (COST) is also on the ground and will remain coordinating efforts.
- The United Nations Office for the Coordination of Humanitarian Affairs (OCHA) will convene an in-person coordination meeting, at 7:00PM local time on November 2nd 2025.
- The Central Emergency Response Fund (CERF) has authorised disbursement of USD \$4 million to UN agencies to boost support efforts. Work is ongoing to determine the most critical priority areas, including health, shelter, water, and food.
- The Global Support and Development (GSD) vessel, MV Dawn is scheduled to arrive in Kingston on November 4th, 2025.



MNCCC

- Canadian Disaster Assessment Team (CDAT) preparing to be deployed to Jamaica.
- Canadian forces operational support hub (OSH) will be stood up at Kingston Airport, with JDF.



EARLY RECOVERY

- No additional updates.



SHELTER

- International Organization for Migration (IOM) organised a Shelter Coordination Meeting today, November 2nd 2025, in Kingston. Key highlights will be shared once available.

EMERGENCY TELECOMS

- The World Food Programme (WFP) Emergency Telecoms Coordinator is scheduled to arrive today.
- Coordination with OCHA and local counterparts is ongoing to establish a coherent strategy for the deployment and management of multiple Starlink kits across Jamaica, ensuring effective planning, cost sustainability, and avoiding duplication or uncoordinated deployment.



HEALTH

- Three Emergency Medical Teams (EMTs) have been approved for deployment: Samaritan's Purse Type 2 EMT – assigned to the Black River area. Spanish Type 2 EMT – deployed to the Cornwall Regional area. Israeli Type 2 EMT – approved by the Government of Jamaica for Falmouth/Savanna-la-Mar (pending integration into the PAHO system).
- Two deployed teams are currently conducting field assessments at hospital sites. Health services have been significantly impacted; while some centers are reopening, many remain damaged.
- A health coordination hub has been established in Santa Cruz as an extension of the Ministry of Health's Emergency Operations Center (EOC).
- Americare, Doctors Without Borders/Médecins Sans Frontières (MSF), and other partners are conducting site visits in Cornwall and Falmouth, to support ongoing assessments.
- Pan American Health Organisation (PAHO) supplies, transported via a Dutch vessel from Barbados, are scheduled to arrive on November 3rd, 2025.
- The next Health Cluster Coordination Meeting is scheduled for Tuesday, November 4th.
- Key priorities include strengthening coordination, avoiding resource overlap, and ensuring efficient allocation of medical support and supplies.



PRIVATE SECTOR

- OCHA and the Connecting Business Initiative (CBI) are tracking private-sector support through national Chambers of Commerce.
- The CARICOM Private Sector Organization (CPSO) reported that relief items from Guyana are being packed on Monday, November 3rd, scheduled to depart on Tuesday, November 4th, and expected to arrive in Jamaica from the Dominican Republic by Thursday, November 6th. Coordination is ongoing with the Office of Disaster Preparedness and Emergency Management (ODPEM), and the consignment details and item list will be shared with CDEMA following the meeting.
- A new Private Sector Coordination Committee has been established at the national level and is now engaging with the Thematic Private Sector Working Group to strengthen collaboration and streamline private-sector relief efforts.

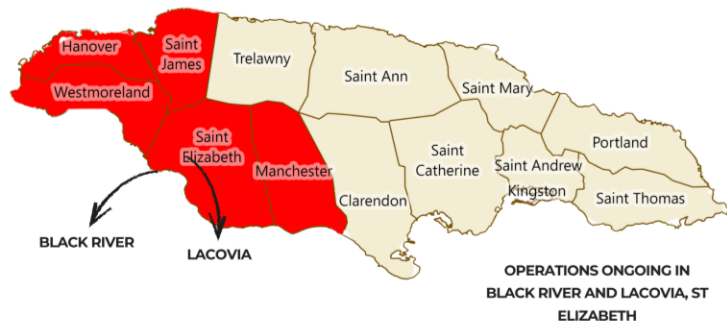

- Large-scale humanitarian distributions began November 1st
- Delivering critical aid daily to the most impacted communities
- Coordinating airdrop missions with Jamaican military

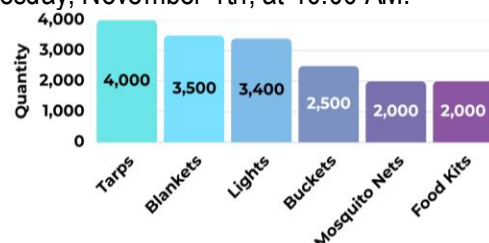
- A consolidation point has been established at the airport, along with the setup of a mobile storage and staging area in Santa Cruz.
- Ongoing efforts are focused on augmenting partner logistics, including the securing of additional warehouse space.
- French vessel, A624 Le Dumont D'Urville is scheduled to arrive on Monday, November 3rd, at 7:00 AM, with offloading at 9:15 AM. Dutch vessel HNLMS Pelikaan (A804) is expected to arrive on Tuesday, November 4th (midday), carrying supplies for four partners.
- Four U.S. State Department-chartered planes carrying tarpaulins and hygiene kits from Miami are expected to arrive throughout the next week.
- An Amazon-chartered aircraft is scheduled to arrive later in the week with additional relief supplies.
- Shelter and medical supplies from the Cayman Islands arrived in Jamaica on November 2nd.
- 34 metric tons of food from the Caribbean Regional Logistics Hub in Barbados arrived in Jamaica on November 1st.
- The next logistics coordination meeting is scheduled for Tuesday, November 4th, at 10:00 AM.

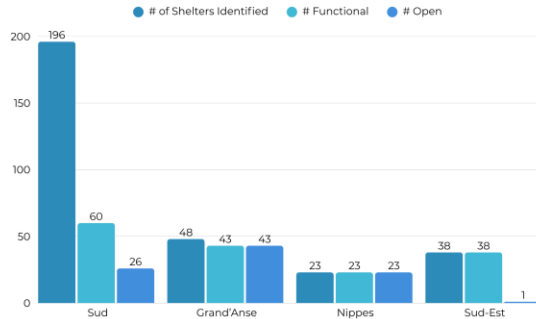

**WASH (JAMAICA)**

- Daily coordination meetings are ongoing, supported by a live tracking system to monitor equipment, supplies, personnel, and mobile water treatment plants.
- The first WASH Rapid Needs Assessment (RNAT) was completed for Trelawny, with findings shared with CDEMA.
- A specialised WASH team has been deployed to Black River to continue assessments; reports are expected later today November 2nd, 2025.
- Engagement is ongoing with the National Water Commission (NWC) to discuss their role and initial impact assessments.
- A meeting with UNICEF and the Quick Response Team is planned to explore support needs for detailed impact assessments and the integration of incoming mobile WASH system plants.
- Efforts are underway to ensure full utilisation and strategic placement of mobile water systems.
- The next WASH Cluster Coordination Meeting is scheduled for Tuesday morning, November 4th. The meeting link will be shared with relevant partners.
