CDEMA CONTINUES TO DEPLOY REGIONAL TEAMS TO SUPPORT JAMAICA'S RESPONSE AND EARLY RECOVERY EFFORTS FOLLOWING HURRICANE MELISSA

OVERVIEW

The Caribbean Disaster Emergency Management Agency (CDEMA) in collaboration with regional international partners continue and deploy support teams to assist in Jamaica's response and early recovery efforts following the impacts of Hurricane Melissa. Three (3) additional CARICOM Operational Support Team (COST) members arrived in Kingston between November 11th and 12th, 2025 to provide strategic advice to the National Emergency Operations Centre operations. Additionally, fifty-one (51) linesmen and engineers from the Caribbean Electric Utilities Services Corporation (CARILEC) were deployed between November 10th and 12th. 2025 to join the existing twenty-four (24) crew members, who arrived on October 31st, 2025. This brings the total number of linesmen and engineers who are supporting electricity restoration efforts, under the Regional Response Mechanism (RRM) to seventy-five (75).

The relief effort in Jamaica is also benefitting from an additional one hundred and seventy (170) metric tonnes of relief supplies facilitated through the CDEMA and the WFP partnership. The relief supplies comprise primarily of food, non-food items and vehicles from the Barbados Department of Emergency Management (DEM), the International Federation of the Red Cross (IFRC), the Pan American Health Organisation (PAHO), ShelterBox, the United Nations Children's Fund (UNICEF). HNLMS Pelikaan (A804) arrived in the Kingston Port on November 12th, 2025.








COORDINATION







84 OF 110 PERSONNEL REMAIN DEPLOYED AS OF 12/11/2025

- ➤ CDEMA deployed three (3) additional CARICOM Operational Support Team (COST) member on request of the Office of Disaster Preparedness and Emergency Management (ODPEM).
- Two mental health and psychosocial support professionals have completed their assignments.
- ➤ A possible extension for some members of the CARICOM Emergency Telecommunications Team (CETT) is being considered.



MNCCC

- Coordination meetings have shifted to Monday, Wednesday and Friday weekly.
- No additional updates presented.



PROTECTION

➤ Gender-Based Violence (GBV) Sub-Cluster Meeting led by the Bureau of Gender Affairs and UNFPA will be held on November 14th, 2025.

EARLY RECOVERY

- The Recovery Thematic Working Group met on November 10th to coordinate and map actors' activities across various sectors. Senior officials from the Planning Institute of Jamaica (PIOJ) attended the meeting.
- ➤ CARILEC deployed an additional fifty-one (51) personnel to support electricity restoration efforts in Jamaica. A total of seventy-five (75) linesmen are now deployed in collaboration with CARILEC.
- > The Regional Agriculture Disaster Risk Management Committee met on November 12th, 2025.
- > Several organisations are conducting assessments with farmers and seeking or allocating early recovery funding.
- > There is an emphasis on resource mapping and engagement with development finance institutions to better channel recovery support.
- ➤ Updates from the Education Sector and detailed subgroup summaries will be provided at the next meeting scheduled for November 14th, 2025.



EMERGENCY SHELTER

- ➤ Eighty-five thousand (85,000) tarpaulins have been mobilised, with thirty thousand (30,000) distributed to date. Distribution is being accelerated through airlifts and partner support.
- Community mobilisation efforts are ongoing to support the safe and efficient distribution of tarpaulins.
- ➤ Jamaica Defence Force (JDF) and community councilors are supporting coordination and providing priority community lists for targeted assistance.
- ➤ Red Cross, Caritas, International Organisation for Migration (IOM), and Samaritan's Purse are leading field distributions of tarpaulins and other non-food items with new communities being added daily.
- > Shelter Technical Working Group (STWG) partners are working with national counterparts to enhance data collection and information flow on both formal and informal shelter use.
- > Debris removal coordination is underway with government agencies to facilitate recovery efforts.
- > Development of a medium-term housing reconstruction strategy is being initiated.
- ➤ A tarpaulin installation leaflet, adapted from Shelter Cluster guidance, is being finalised by the STWG and local engineers.
- An instructional video on safe tarpaulin installation is being prepared with collaboration and videography support from the JDF.

EMERGENCY TELECOMS

PRIVATE SECTOR

RELIEF & LOGISTICS

- Field points of contact have been established and are actively coordinating operations.
- > The Log IE (logistics mapping) system is being continuously updated to track relief activities.
- Mobile Storage Units (MSUs) have been set up in Montego Bay, with expansion planned for Kingston.
- > Partners are reminded to regularly enter data to support Control Tower operations.
- ➤ The HNLMS Pelikaan (A804) vessel arrived on November 12th, 2025 to provide additional support for relief logistics.



WASH

- > A coordination meeting was held with strong participation from the National Water Commission (NWC).
- > The UNICEF WASH team is currently in the field, with further updates expected by this evening.
- Logistical support is needed for utility reconnections as identified by the NWC.
- > Shipments of equipment and materials are expected from Miami (Billy's Water Services), with another shipment from The Bahamas pending a formal request.
- > Partners have been asked to confirm their ability to assist with logistical needs associated with these shipments

HEALTH

- CARPHA is engaging with the UK Health and Safety Executive (HSE) and the Pandemic Fund to provide support to Jamaica.
- ➤ A roster of trained medical professionals is being compiled to assist with field hospital operations and Emergency Medical Team (EMT) support for the Barbados Defence Force and PAHO teams.
- ➤ PAHO Jamaica continues Health Cluster coordination, with the 5th meeting held on November 11th, 2025 focusing on partner mapping and commitments; data from twenty-four (24) teams has been included.
- > A capacity and resource dashboard is being developed to support partner coordination.
- Mental Health and Psychosocial Support (MHPSS) activities are ongoing, including PAHO-led training on psychological first aid.
- ➤ Emergency Medical Teams (EMTs): twelve (12) EMTs are deployed in partnership with the Ministry of Health. Two Type 2 EMTs are operational in Black River and Falmouth, with the Barbados Defence Force EMT expected to arrive by the end of the week. Nine (9) Type 1 EMTs are supporting primary care in the worst-affected areas.
- ➤ Water, Sanitation, and Hygiene (WASH): Joint efforts with UNICEF are underway to assess WASH conditions in health facilities and identify priority needs.
- > A health sector needs list is being updated and will be shared with partners.
- Rapid damage assessments have been completed, and next steps include conducting definitive assessments using SMART standards.
